### **Euro Medium Term Note Programme**

This Supplement (the "**Supplement**") to the Prospectus dated 28 May 2015 as supplemented by the supplements dated 16 July 2015, 25 September 2015, 29 October 2015, 15 February 2016 and 4 April 2016 (the "**Prospectus**"), which comprises a base prospectus, constitutes a supplementary prospectus for the purposes of Section 87G of the Financial Services and Markets Act 2000 (the "**FSMA**") and is prepared in connection with the €3,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by Akademiska Hus AB (publ) (the "**Issuer**").

Terms defined in the Prospectus have the same meaning when used in this Supplement. This Supplement is supplemental to, and should be read in conjunction with, the Prospectus.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (having taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

### **Purpose of the Supplement**

The purpose of this Supplement is (a) to incorporate by reference the Issuer's Interim Report for 1 January 2016 to 31 March 2016 (the "**Interim Report**") and (b) to update the significant change statement set out in the Prospectus.

### **Interim Report for 1 January 2016 to 31 March 2016**

On 28 April 2016, the Issuer published its Interim Report which contains its unaudited consolidated interim financial statements as at and for the three-month period ended 31 March 2016. A copy of the Interim Report has been filed with the Financial Conduct Authority and, by virtue of this Supplement, is incorporated by reference in, and forms part of, the Prospectus.

The Issuer will provide, without charge, to each person to whom a copy of this Supplement has been delivered, upon the request of such person, a copy of any or all of the documents which are incorporated in whole or in part by reference herein or in the Prospectus.
